BUSINESS MGR & INT'L REP REPORT by Dan Olson

Brothers & Sisters

Hello all 1091 apprentices, journey-workers, and retirecs. First and foremost, I hope you and your families are safe, well, and healthy. What a crazy year this has turned out to be. 2020 was to be a banner year for work but due to the COVID 19 our scope of work has diminished somewhat and we still have unemployment in August.

Many of our jobs have been postponed or downsized for the year. As you look at the Duluth skyline you will see 3 tower cranes at Essentia Health. That hospital and St. Luke's will help keep many 1091 members working this winter. The Husky Refinery is still in a re-build process in Superior, WI and we have some good Union work in Ashland.

We were able to negotiate good contracts this past April with \$1.95 a year for 3 years in the Building agreement and \$2.05 a year for 3 years in the MN Heavy/Highway agreement. WI Building is also \$1.95 a year for 3 years and WI Highway Heavy was \$1.30 this year. Your pension benefit in MN is 86.5% funded and WI is at 84%. Both plans are listed in the green zone for now with no major plan adjustments peeded.

Back in May we held our nomination meeting for the election of officers (3 year term). I am proud, and humbled with humility to announce there were no contested races and your current officers are listed on page 3. Thank you for your support of me & your Board. I pledge to you that I will move this Local, State, Regional, and International Union forward with strength and dignity and I will represent you all to the best of my ability.

Please stay tuned to any changes we may have to make in the near future due to the COVID 19. Our office staff has all been tested and we are using all the State & Federal guidelines to protect you if and when you visit your union office here in the Labor Temple.

Onto some International business: The \$2.6 Billion Line 3 MN has been delayed again and the Department of Commerce will be allowed to appeal the MN Public Utilities decision on the certificate of need and the route. Line 5 (roughly \$100 Million) in WI is in the permitting stage and could possibly start construction in the 1st quarter of 2021. Follow us on Facebook, LIUNA Local 1091, for important updates. NTEC, Nemadji Trail Energy Center, is also in the permitting process for a \$700 million natural gas power plant in Superior. This plant will supplement existing energy needs now and into the foreseeable future.

2021 will see an increase in monthly dues to meet the requirement of the 25th LIUNA Convention. Next year will also be the 26th National Convention to be held in September. In closing, thank you for all that you do. And now more than ever I need you to vote in the elections. Vote by mail, vote absentee, vote early, or visit your polling place on November 3rd. I need you to stay engaged in your, our Local 1091 Union. Monthly membership meetings are the 3rd Thurs. of every month and they are the easiest yet most important way to stay strong and united. With all that being said, Feel the Power, Be the Power, and Use the Power of LIUNA. Be safe, healthy, and prosperous.

APPRENTICESHIP: Duluth Orientation 12/10/2020 @ 5:00 p.m.

To ALL Apprentices: Although we are in the midst of a busy construction season, remember, you all need to be thinking about registering & taking training classes. After your time off, all Apprentices are required to complete a minimum 100 classroom hours based off of the Initiation date. Every year, any Apprentice behind in classroom hours will be assessed double working dues until the required schooling has been completed.

All Apprentices must complete 288 training hours and 4000 work hours in three (3) years from their Initiation date to upgrade to Journey-worker. The 3 mandatory classes required for Apprentices to complete the program are Safety Week, General Construction, and Orientation.

The Safety Week will be offered in Duluth December 07—11, 2020 with an Orientation being held on the following Thursday evening (the 17th) prior to our regular union meeting. Both Safety Week and General Construction are 40 Hour classes. In addition to, each Apprentice will receive 4 hours of training for completing the Orientation and 2 hours of training for each Union meeting they attend. When attending these meetings be sure to indicate when signing in that you are an Apprentice to ensure that you will receive credit for your attendance.
